ST GEORGE DISCOVERS MASSIVE NICKEL-COPPER SULPHIDES IN MAIDEN DRILLING AT INVESTIGATORS PROSPECT

HIGHLIGHTS:

- Massive nickel-copper sulphides discovered in the previously unexplored Investigators Prospect
- MAD31 has intersected massive sulphide mineralisation at 112m depth in the extremely conductive Anomaly 2 (86,500 Siemens)
- MAD32 has intersected massive sulphide mineralisation at 52m depth testing an offhole downhole electromagnetic (DHEM) plate from MAD24
- Pure pentlandite vein with 28%Ni (based on field XRF analysis) within the massive sulphides in MAD31
- Downhole EM survey in MAD31 indicates the strongest part of Anomaly 2 is just north of the drill hole suggesting potential for extensions of the high grade mineralisation
- Downhole EM and geological modelling continue to deliver exploration success
- Multiple discoveries of massive nickel-copper sulphides over a broad area support the emergence of a new nickel sulphide camp at Mt Alexander

NEW DISCOVERY OF MASSIVE NICKEL-COPPER SULPHIDES AT INVESTIGATORS

St George Mining Limited (ASX: **SGQ**) ('St George Mining' or 'the Company') is pleased to announce that massive nickel-copper sulphides have been discovered in the maiden drilling programme at the Investigators Prospect in the Mt Alexander Project in Western Australia.

Drill holes MAD31 and MAD32 targeted separate downhole EM conductors at the Investigators Prospect, and both drill holes have intersected massive nickel-copper sulphides hosted by mineralised ultramafics which have been intruded by later granites.

MAD31 tested Anomaly 2 at Investigators and was drilled to a downhole depth of 160m. The drill hole has intersected approximately 15m of ultramafic with occasional blebby and disseminated sulphides increasing downhole and then massive nickel-copper sulphides from 112.05 to 113.08m downhole.

The massive sulphides in MAD31 include a pentlandite vein that runs most of the length of the intersection with an average nickel value (based on field XRF analysis) of 28%Ni.

Further details of the sulphide mineralisation intersected by MAD31 from 97 to 113.08m are:

 15.05m, from 97-112.05m, of occasional blebby and disseminated sulphides increasing downhole to 0.4m of matrix sulphides from 111.5m (spot XRF readings of the matrix sulphides average 2%Ni, 1%Cu)



• 1.03m, from 112.05-113.08m, of massive sulphides with spot XRF readings ranging 2%Ni to 28.6%Ni (average 7%Ni) and 0.5%Cu to 4.5%Cu (average 2.5%Cu)

MAD32 was completed to a downhole depth of 92.7m to test an off-hole DHEM conductor that was identified from drill hole MAD24 and was modelled at a depth of 50m. MAD32 intersected approximately 12.7m of ultramafics from 42m with some blebby and disseminated sulphides and then massive nickel-copper sulphides as summarised below:

- 11.76m, from 42-53.76m, of occasional blebby and disseminated sulphides increasing from 51.1m
- 0.77m, from 52.76-53.53m, of massive sulphides with spot XRF readings ranging 1.7-16.4%Ni (average 8%Ni) and 0.4-2.9%Cu (average 2%Cu)

St George Mining Executive Chairman, John Prineas said:

"The new discoveries at Investigators and Stricklands, with evidence of exceptionally high grade mineralisation, highlight the increasing prospectivity of the underexplored Mt Alexander Project.

"The successful drilling by St George has significantly expanded the size of the high grade nickel-copper system in the Cathedrals Belt and established Mt Alexander as a new and significant nickel sulphide project in Western Australia."

The metal values quoted are based on field XRF analysis and are preliminary only. The metal values for intervals of massive nickel-copper sulphides are based on XRF analysis at 10-20cm spaced readings.

Based on the intersection angle of the drilling and interpreted EM plates, the down-hole widths are interpreted to be near to true widths, but will be reviewed again with DHEM results.

DHEM SURVEY IN MAD31 - POTENTIAL FOR EXTENSIONS OF MINERALISATION

A DHEM survey in MAD31 has indicated that the strongest part of Anomaly 2 is located to the left (north) and slightly above the pierce point of MAD31. The DHEM plate for this stronger response may represent a thicker section of the massive sulphide mineralisation intersected by MAD31. Newexco is currently finalising a new model designed to continue testing this high grade nickel sulphide mineralisation.

Anomaly 3 at Investigators, which has yet to be drilled, is situated approximately 15m to the west of Anomaly 2, and at the same depth as the ultramafic intersected by MAD31. The location of Anomaly 3 relative to the massive nickel-copper sulphides in MAD31 indicates potential for continuity of mineralisation along the Investigators ultramafic.

INVESTIGATORS CONFIRMED AS A NEW MINERALISED PROSPECT

The discovery of massive nickel-copper sulphides within a mineralised ultramafic at the previously unexplored Investigators prospect is another significant milestone for exploration at Mt Alexander.

The massive sulphide mineralisation in MAD31 at Investigators is approximately 900m further west from the high grade mineralisation discovered by St George at Stricklands, which itself is a further 1km west-southwest of the initial discovery of nickel-copper sulphides made by BHP Billiton in 2008 at Cathedrals.

The drilling by St George has confirmed that the sulphides within mineralised ultramafics in the Cathedrals Belt extend intermittently for over 2.5km, with further targets to be tested.




Figure 2 – a plan view of the Cathedrals Belt (over TMI magnetics) showing the drill hole collar locations in the current programme. MAD25-MAD32 are the drill holes completed to date.



CURRENT DRILL PROGRAMME

Table 1 shows drill hole details for holes completed or underway in the current diamond drill programme.

Drill hole MAD33 is currently underway to test the second of the strong off-hole conductors identified from the DHEM survey in drill hole MAD24.

XRF ANALYSIS:

References to XRF results and to portable XRF analysis relate to analysis using a hand-held Olympus Innov-X Spectrum Analyser. This portable device provides immediate analysis of modal mineralogy of drill samples.

Portable XRF analysis is able to detect base metals, like nickel and copper, though values are considered less reliable in disseminated sulphides due to the finer grain and interstitial textures. The XRF device is more reliable for detection of base metals, like nickel and copper, within massive sulphides.

Results from XRF analysis are stated as indicative only and are preliminary to subsequent confirmation by laboratory assays.






Figure 3 – a map (over TMI magnetics) showing the location of Mt Alexander Project to the south-west of major nickel projects in the Agnew-Wiluna Belt. The Mt Alexander Project is favourably located close to existing infrastructure and nickel sulphide processing facilities.

ABOUT THE MT ALEXANDER PROJECT:

The Mt Alexander Project is located 120km south-southwest of the Agnew-Wiluna belt which hosts numerous world class nickel deposits. The Project comprises three granted exploration licences – E29/638, E29/548 and E29/962.

The Cathedrals, Stricklands and Investigators nickel-copper discoveries are located on E29/638, which is held in joint venture by Western Areas Limited (25%) and St George (75%). St George is the Manager of the Project with Western Areas retaining a 25% non-contributing interest in the Project (in regard to E29/638 only) until there is a decision to mine.
